We convene disparate voices and perspectives to engage in dialogue, come to a common understanding and move forward with a shared solution. Our policy work advances utility and government energy efficiency and renewable energy programs, including building codes, equipment standards, low-income and equity-focused energy programs, distributed generation, renewable energy portfolio standards, and coal plant retirement strategies. Policy work analyzes utility regulatory issues including rate design, utility business models, electrification of transportation, and the energy system impacts of operational changes to the hydroelectric dams in the Columbia River basin.

OUTREACH: The NW Energy Coalition hosts on two Clean & Affordable Energy conferences per year. These events bring together diverse players and perspectives engaged in clean energy and climate issues in the Northwest. We provide ongoing outreach and education to our approximately 100 organizational members and our many individual members in order to keep them informed and engaged in advancing clean and renewable energy policy in the region.

COMMUNICATIONS: The organization issues regular communications via alerts, press releases, fact sheets and newsletters.
