Some of these cohort members have been involved since the Oregon Green New Deal Listening sessions in 2020 that ultimately created the Oregon Clean Energy Opportunity campaign which helped to advance HB 2021, HB 2475, and HB 2842. The group has met regularly over the past year to share ways to be more involved in PUC processes, understand regulatory and technical language of utility

Sam is a maestro of community and government collaboration. He works to bring together a diverse ensemble of stakeholders towards a shared vision for climate justice in Portland. Prior to his role at the City, Sam served as a senior policy advisor in Multnomah County's Office of

They have three adult daughters Deborah, Sarah, and Miriam.



Emeka Anyanwu (he/him), Seattle City Light

Emeka has been with Seattle City Light since March 2018 and leads the utility's business unit responsible for work in innovation strategy, transportation and building electrification, grid modernization, implementation of strategic grid technologies, and the utility's IT and OT technology strategy, and cybersecurity functions. He is also responsible for overseeing regional affairs and trade organization engagements, power resource management functions, and the power marketing operations of the

Aja DeCoteau is a citizen of the Confederated Tribes and Bands of the Yakama Nation and has other tribal lineage with the Cayuse, Nez Perce and Turtle Mountain Band of Chippewa Indians. She has over twenty years of experience working on natural resource management and policy issues in the Columbia River Basin. Prior to serving as the Executive Director, she was CRITFC's Watershed Department Manager

where she coordinated fisheries restoration and watershed protection activities and researched climate change response on behalf of the Yakama, Nez Perce, Umatilla, and Warm Springs tribes.

Senator Kate Lieber (she/her), Oregon State Senate

Senate Majority Leader Kate Lieber represents Senate District 14, which includes Beaverton and SW Portland. Senator Lieber is a mother of two, a breast cancer survivor, a former community college instructor, and an attorney. As a State Senator and the Senate Majority Leader, she continues to work to ensure the state government is solving the most pressing problems facing Oregonians, from the homelessness crisis and community safety to wildfires and rising prices.



Rich Glick, GQ New Energy Strategies

Rich is a Principal with GQ New Energy Strategies – a consulting firm he co-founded with Pamela Quinlan. He recently completed a five-year term as a Commissioner with the Federal Energy Regulatory Commission (FERC) where he chaired the Commission for two years. As Chairman, Rich initiated several key initiatives, including proposals to reform the planning and cost allocation process for electric transmission; expedite and enhance the generator interconnection process; improve the operation of organized electric capacity markets; and protect the reliability of the electric grid against weather-related, cybersecurity, and physical attack threats.

Diego Rivas (he/him), NW Energy Coalition

Mariel is an environmental law and policy specialist leading Front and Centered's commitment to advancing the clean energy interests of frontline communities in Washington that are historically disproportionately harmed by climate change. West Africa, where she observed the important interplay of communities, institutions and infrastructure in supporting resilient and equitable socioeconomic systems. The Headwaters Award honors achievement and leadership by a person who is directly involved in NWEC and who excels in advancing our collective goals and mission. And by Headwaters, we are of course talking about the headwaters of the Columbia River in Columbia Lake in British Columbia – at an elevation of 2,690 ft above sea level.

Todd is a senior attorney at Earthjustice's Northwest regional office in Seattle and was one of two attorneys who opened the office in 1987. Todd is a champion for salmon recovery. Over the past 20+ years he has taken the time to learn about and understand energy system operations and how the hydropower system works. He has led long, arduous and successful litigation to avoid species extinction and recover healthy and abundant salmon populations.

Doug Still was a founder of the Coalition and a community organizer for over 60 years. This award honors individuals or organizations for their commitment to directly engaging citizens in taking action for a clean, affordable, and equitable energy future.

Front and Centered is a diverse and powerful coalition of communities of color-led groups across Washington State, whose missions and work come together at the intersection of equity, environmental and climate justice. Together, and with key partners the coalition actively works towards the vision for a Just Transition. Front and Centered practices equitable governance principles, guided by a Community Council which oversees Front and Centered's portfolio of policy, programs, and capacity building efforts.

Bob Olsen Memorial Conservation Eagle Award

Green Energy Institute (GEI) at Lewis and Clark Law School

In recognition of your leadership to create a clean, equitable, and affordable energy future



The Eagle is awarded annually to recognize individual or organizational leadership for a clean, affordable, and equitable energy future. Bob Olsen was a visionary leader within the public power utility community and NWEC, and one who pushed hard to advance energy efficiency as a means to delay new power generation before conservation and efficiency were established resources.
